- Your words may be quoted in scholarly and popular publications, including in scholarly journals, newspapers, audiovisual presentations, exhibits, and websites.

Please understand that there is nothing in this Presenter/Performer Release requiring you to give your ideas to SCUA and that SCUA's goal of making the Recordings and Materials available to the public will not prevent you from making use of them in any way you wish. If you plan to give the same presentation or performance somewhere else, there is nothing in this release that would keep you from that engagement.

CREATIVE COMMONS LICENSING:

SCUA is committed to using your presentation in ways that respect your interest in your copyright and creative work in the Recording while encouraging potential researchers who may wish to use it.
