
Choose a type of legal structure:




Churches have many tax and legal advantages.


Sometimes individual preachers ("nondenominational ministries") and dubiously-religious groups try to claim church status.

Choose "Banking purposes," most likely...




#### Choose "Individual."

The Responsible Party is "the true principal officer, general partner, grantor, owner or trustor.

This individual or entity, ... controls, manages, or directs the applicant entity and the disposition of its funds and assets.


If there is more than one responsible party, the entity may list whichever party the entity wants the IRS to recognize as the responsible party."
