HOW DOES A FAITH AND PRACTICE ORIGINATE?



- Each yearly meeting writes its own *Faith and Practice* to reflect its faith and experience.
- We trust in continuing revelation to meet our times.
- Currently, we are re-envisioning NEYM's *Faith and Practice*, rather than revising or adapting the previous edition.

THE CHARGE: to create the text



In 2001, people said:

- “We haven’t had a new *Faith & Practice* since 1985!”
- “We are changing; we need to reflect this new life.”
- “There are lots of new members. How do we share what is important?”
- “We need to name our faith and our practices carefully. We need more detail.”

Permanent Board authorized work on a new edition in 2001.

THE CHARGE:

to widen and deepen the dialogue



The review committee asked:

- How can the process of revising our *Faith and Practice* deepen our spiritual life—individually and corporately?
- How can the process help the YM to engage with its own book of *Faith & Practice*?
- How can the process help us gain a sense of where we are now, and how we have changed since 1985?

- And a diversity of life experience



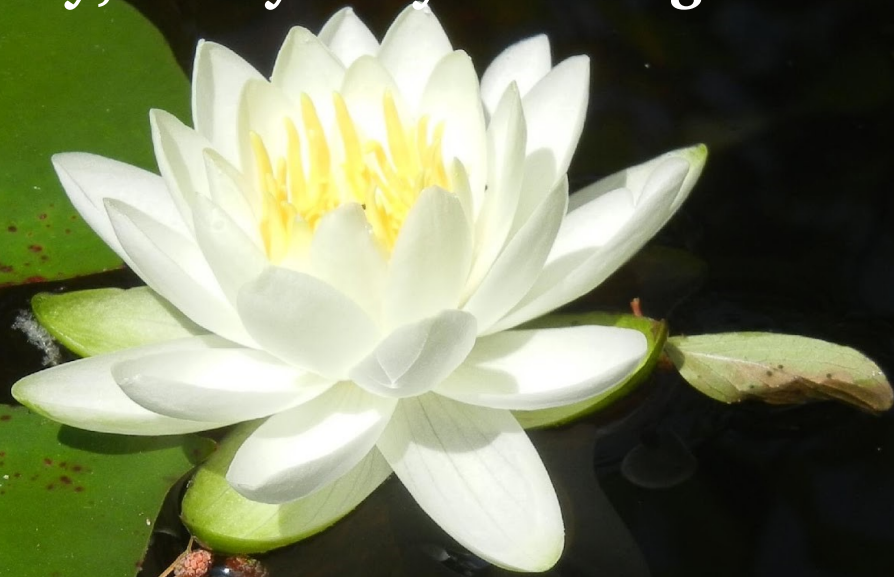
